CDCC Meeting Minutes for October 7, 2010

## **Welcome to New Members / Guests:**

The meeting was called to order at 7:43 PM by President Phil Trifaro who welcomed 14 members. There were no guests present.

## **September 2010 Meeting Minutes:**

A lengthy discussion was held on possible changes. A membership decision was made to move to a non-judged show accepting all years, makes, and models of vehicles. A possible "Top 20" selected by CDCC members might be used plus possible extra trophies selected by participants, spectators, the DJ, CDCC ladies, etc. Details of the show will to be worked out at future committee meetings, with reports back to the membership. The next Car Show Committee meeting has been scheduled for Tuesday, Oct. 26 at 6 PM at the diner.
